CITY PLANNING COMMISSION MEETINGS ON THE **THIRD WEDNESDAY** OF EACH MONTH ARE RESERVED FOR **SPECIAL EXCEPTION CASES**. *THE SUBMISSION DEADLINE IN THE FIRST COLUMN CORRESPONDS HORIZONTALLY TO THE PLANNING COMMISSION MEETING IN THE SECOND COLUMN.* **HOWEVER, IF A MEETING IS CANCELED, REQUESTS FOR REZONINGS, CONDITIONAL USE PERMITS OR SPECIAL EXCEPTIONS WILL BE MOVED TO THE NEXT REGULARLY SCHEDULED MEETING.**

Applications for rezoning, conditional use permits, variances and special exceptions cannot be processed if there are delinquent real estate taxes and/or stormwater fees owed to the city against the subject property.
