<u>Residential:</u> \$1.51 per month <u>Commercial:</u> \$1.29 + \$0.067602 per CCF on the first 128.91 CCFs (Tier One), + \$0.032576 per CCF on all remaining CCFs (Tier Two), total tax not to exceed \$55.00 per month. <u>Industrial & Other Classes of Non-Residential Consumers:</u> \$1.29 + \$0.067602 per CCF on the first 128.91 CCFs (Tier One), + \$0.032576 per CCF on all remaining CCFs (Tier Two), total tax not to exceed \$55.00 per month.
