A RESOLUTION AUTHORIZING AND DIRECTING THE CITY MANAGER TO EXECUTE AND THE CHIEF DEPUTY CITY CLERK TO ATTEST, ON BEHALF OF THE CITY OF NEWPORT NEWS, VIRGINIA, THAT CERTAIN ADDENDUM NO. 11 DATED THE 28<sup>TH</sup> DAY OF JUNE, 2016, TO THE AGREEMENT BETWEEN THE CITY OF NEWPORT NEWS, VIRGINIA, AND MABEL WASHINGTON JENKINS, FORMERLY KNOWN AS MABEL V. WASHINGTON, CITY CLERK.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Newport News:

1. That it hereby authorizes and directs the City Manager to execute and the Chief Deputy City Clerk to attest, on behalf of the City of Newport News, Virginia, that certain Addendum No. 11 dated the 28<sup>th</sup> day of June, 2016, to the Agreement between the City of Newport News, Virginia, and Mabel Washington Jenkins, formerly known as Mabel V. Washington, City Clerk, which will amend the City Clerk's compensation as stated in Addendum No. 11 of said Agreement. All other terms and conditions of the Agreement dated December 1, 2004, as previously amended, shall remain in full force and effect except to the extent they may be modified by this Addendum. That a copy of Addendum No. 11 is attached hereto.

2. That this resolution shall be in effect on and after the date of its adoption, June 28, 2016.

**ADDENDUM NO. 11**

THIS ADDENDUM NO. 11, dated the 28<sup>th</sup> day of June, 2016, to that certain AGREEMENT dated the 1<sup>st</sup> day of December, 2004, by and between the **CITY OF NEWPORT NEWS, VIRGINIA**, a municipal corporation of the Commonwealth of Virginia, and **MABEL WASHINGTON JENKINS**, formerly known as **MABEL V. WASHINGTON**, City Clerk.

**WITNESSETH:**

For and in consideration of the following terms, conditions, mutual covenants and other good and valuable considerations, the receipt of which is acknowledged between the parties hereto, it is mutually agreed as follows:

The AGREEMENT dated December 1, 2004, by and between the **CITY OF NEWPORT NEWS, VIRGINIA** and **MABEL V. WASHINGTON**, is hereby amended, effective July 1, 2016, by changing the paragraph listed below of the aforesaid AGREEMENT, to provide as follows:

4. The City shall pay to the Clerk the amount of One Hundred One Thousand One Hundred Ninety-Five Dollars and Eighty-Two Cents (\$101,195.82) per annum, as salary. In addition to this salary, the City shall pay on behalf of the Clerk deferred income in the amount of Eight Thousand Dollars (\$8,000.00) per annum, which shall be paid into a portable retirement plan(s) designated by the Clerk.

All other terms and conditions of the Agreement dated December 1, 2004, as previously amended, shall remain in full force and effect except to the extent they may be modified by the provisions hereof.
